Financial Statements

a.) Review & Accept the December 31, 2021, January 31, 2022, & February 28, 2022, Unaudited Financial Statements

Kite reported as of February 28, 2022, the operating account had \$20,200.13 and the reserve account had \$396,968.70 including the Certificate of Deposit Accounts. The CIT bank Reserve cash has \$294,396.68 which exceed the \$250,00.00 insurable limit. The board approved \$100,000.00 to be put into a money market account to satisfy the FDIC limits. However, CIT responded that a money market would not be sufficient because it uses the same bank ID number. He provided information for Certificate of Deposits accounts for consideration.

MOTION: H. Tolles moved to accept the September 30, 2021, financial statements. C. Passow seconded the motion, which carried unanimously

b.) Investment Options for CIT Reserve Account (exceeds \$250,000.00 insurable limit)

The current CIT Bank Reserve Cash account has \$289,114.63 which exceeds the \$250,000.00 insurable limit. Management provided Certificate of Deposit options and the board discussed the possibility of opening a separate reserve bank account under a different bank.

MOTION: H. Tolles moved to approve a 9-month Premium Ladder CD for \$100,000.00 from the Reserve Checking account beginning 4/1/2022. S. Durst seconded the motion, which carried unanimously

a.) 4/1/22 - 4/1/23 Landscape Maintenance Contract-Reno Green Landscaping-Review/Approval The board reviewed the 4/1/22 - 4/1/23 Landscape Maintenance Contract submitted by Reno Green Landscaping. The renewal contract is in the amount of \$820.00 which is \$150.00 increase. H. Tolles requested the sign the scope of work and attach to the contract for signature.
