### **Old Business**

a.) Sewer Clean Out- SNC

The board discussed the sewer maintenance that has been completed by SNC. They finished scoping the last line on North Claridge (about 15' from the manhole in Lancaster Apartments to N. Virginia.) The board also had them camera and check the South Claridge Side. SNC discovered a damaged sewer line that will need to be repaired to prevent a collapse. They will have to go through the asphalt to make the repair. The association is waiting for a date the repair can start.

# a.) 9/1/24 – 9/1/25 Cyber Security Policy- American Family
